FREQUENTLY ASKED QUESTIONS

	QUESTIONS		ANSWERS	
Q1.	Who is eligible to vote in the Lake View Credit Union director election?	A1.	All members (except junior members) of Lake View Credit Union in <i>good standing</i> are eligible to vote. Good standing is defined in the rules as a member who: (a) has purchased, paid for and holds the number of Class "A" Membership Equity Shares required by the Rules; (b) is not delinquent in any obligation to the credit union	
Q2.	How long do you need to be a member before you can vote?	A2.	You must have been a member for at least 120 days prior to the election	
Q3.	How old do you need to be to vote?	A3.	Nineteen (19) years or older. No junior members are able to vote.	
Q4.	Who is <i>not</i> eligible to vote?	A4.	Unincorporated organizations or societies and/or members under 19 years old.	
Q5.	How many votes can I have?	A5.	Each member gets ONE vote. One member, One vote	
Q6.	What if I have more than one account?	A6.	Voting is based on membership. One member, one vote, regardless of how many accounts you have.	
Q7.	What if I have a joint account?	A7.	Voting eligibility is based on Equity Share accounts – every member has their own individual equity share account.	



Q8.	Can m	/ business	vote?

A8. Incorporated or limited companies are eligible to vote by proxy of a nonmember which preserves the one member, one vote rule.

Voting by proxy means that you appoint someone you trust to vote on your behalf.

Proxy must be received ten (10) days prior to the election start in order for the business to cast a vote. If you receive questions about this from a member, please contact Selina Lajeunesse

On March 4, 2025, a current director has unexpectedly tendered his resignation from the Lake View Credit Union Board of Directors. The election will now be for four available seats: three with 3-year terms and one with a 2-year term. Please vote for the three candidates you would like to elect for the 3-year terms. The candidate with the fewest votes will be elected for the 2-year term.
